DISCUSSION AND POSSIBLE ACTION: W.D. MAYO HYDRO ELECTRIC PLANT GRANT

Councilor Thornton introduced Mr. Roger Knight of the U.S. Department of Labor Division of Energy and Mineral. Mr. Knight gave a brief overview of his background and the W. D. Mayo Hydroelectric plant. He commented there are some upcoming funds available and a resolution would be needed at that point. Councilor Cowan Watts requested a copy of the environmental impact statements along with the minimum flow requirements. Councilor Thornton commented CNB would be coming forward with the resolution in the near future and today just need to know it will have the support of the Council. Councilor Walkingstick recommended they meet with CNB and then have CNB report back to this body. Councilor Buzzard inquired as to what has been done to date with the other funding.
