Councilor Baker moved to approve the February 26th regular session minutes as submitted. Councilor Keener seconded the motion. The motion carried.

STATE OF THE NATION Bill John Baker Principal Chief

> Principal Chief Baker requested the twelve Youth Councilors present introduce themselves. He requested Superintendent of Sequoyah High School, Leroy Qualls, pass the Girls basketball team gold ball around. He gave highlights of the other area basketball teams in the State playoffs. The one year anniversary of the opening of the Veteran's Center was celebrated last week. He announced one hundred Cherokees have jobs in Nowata County now thanks to the South Coffeyville casino. Our Health Department and clinics have received certified healthy honors from the State Health Department. Cherokee Days in Washington D.C. is coming up soon.

The Macy's Development in Owasso will begin hiring soon and will be open on the 1st of April. The Annual School Appreciation Luncheon will be held March 27th at Hard Rock Casino. The Cherokee Capitol Building will undergo restorations soon. They just returned from Dallas where a Cherokee At Large meeting was held. Principal Chief Baker made a very special announcement to the Tribal Council in that we have been extremely successful with Lloyd Miller as our Contract Support Cost attorney. Mr. Miller and his law firm made a joint contribution of \$200,000 to the Cherokee Nation to go toward the construction of the Cherokee Nation health care facilities. Chief Baker recognized Cherokee Citizen Mason Fine the Locust Grove quarterback and class president. Chief Baker requested a moment of silence for those Cherokees who have passed over the last month.

#### Housing Authority - Gary Cooper

*Mr.* Cooper announced the next regular board meeting for the Housing Authority will be Thursday, March 26th. They continue to work closely with the National American Indian Housing Council and others to see NAHASDA reauthorized this year. They also continue to work on Negotiated Rule Making and other issues. The Housing Authority will soon be able to access HUD Vash funds which are for homeless Native American Veterans. He provided an update on the college housing assistance program.

#### Cherokee Nation Business, LLC - Shawn Slaton

*Mr.* Slaton gave the financials for December and announced January was an all-time record. He provided an update on all of the current projects. An announcement was made last week that they will be partnering again with Bass and the Tulsa Chamber to bring back the 2016 Geico Bass Master Classic to the Grand Lake area. He gave highlights from the opening of the South Coffeyville casino. He commented on the airing of the second episode of the Cherokee Voices on Channel 8. He reported Chad McReynolds has been named the new General Manager at Roland. They currently have 6,100 employees and 4,706 when the contract and temporary employees are excluded. They currently have 74.1% Cherokees employed, 7.9% other Native American for a total Native American employment of 82%. He offered to answer any questions.
