NEW BUSINESS

1. <u>15-064</u> A RESOLUTION AUTHORIZING THE ACCEPTANCE OF LAND IN TRUST - OAKS MISSION SCHOOL (ROCKY FORD) 5.0 ACRES

Councilor Glory Jordan moved to approve. Councilor Hargis seconded the motion. All Councilors present requested to be added as sponsors. Clarification was requested on the name and location of the property. Mr. Davis commented the building is in bad shape.

Councilor Buzzard made a motion to add "formerly Rocky Ford" to both the title and the body of the resolution. Councilor Cowan Watts seconded the motion. After additional discussion was held the motion failed with the following roll call vote:

2. TMP-305 CHEROKEE NATION WASTE MANAGEMENT - STATUS REPORT

Board member Fan Robinson and Director Jamie Clinton provided a written report and a status update on the landfill. They commented they were unaware their monthly report given to Environmental didn't make it to the Council. They provided a list of accomplishments of the current Board over the past two years. Councilor Hargis requested a report of the current cell, the cost of a new cell, and the number of current contracts. With the current rate the current cell will be full this December. Councilor Glory Jordan inquired if a budget has been submitted to the Administration for consideration during our budget hearings. After numerous questions regarding a

new cell, closure and costs they were asked to provide a business plan and an annual bare bones budget. Mr. Clinton stated he would provide a couple of scenarios 1) throttle down and just provide a local trash service and 2) increase volume, get a new cell and break even.
