STATE OF THE NATION

Bill John Baker Principal Chief

Speaker Byrd announced the Council has had a long day with committee meetings starting at 9:00 a.m. this morning and a Thanksgiving lunch provided by the Head Start.

Principal Chief Bill John Baker announced he is returning today from community meetings in Arizona. Last week we were able to pass on a grant to the NORA Summit for economic development. We hosted the CDC Administrators for the

Hepatitis C cure partnership. Our Secretary of State represented us well at the White House at the Tribal Leaders Conference last month. Ground was broke for a new community building in Nowata. Chief Baker congratulated Speaker Byrd as he was elected the Northeast Oklahoma Regional Vice President for the National Congress of the American Indians. Speaker Byrd replaced the outgoing Deputy Principal Chief S. Joe Crittenden. Chief Baker and our Health Director, Connie Davis, presented Craig Edgemon, a public health nurse at our Sallisaw clinic, with a plaque for his heroic efforts. Chief Baker requested a moment of silence for those Cherokees who we have lost over the past month.

Cherokee Nation Business. LLC - Shawn Slaton

Mr. Slaton reported on the September financials and announced a very successful 2015 for the businesses. They contributed \$300,000 in tax collection in addition to the tribe. He provided a project update including Outpost #1 and the Roland facility. He announced they secured a contract with the Army National Guard in thirteen states for Cherokee Nation Health Care Services to help insure soldiers are physically fit to deploy. Mr. Slaton announced they are supporting National Heritage month by offering free museum admissions for the month of November. Also for the month of November at the Veterans Center here in Tahlequah there will be a display of information regarding the Cherokee Code Talkers. The Osiyo Voices of the Cherokee People show will expand to the Oklahoma City area. The first season of the show will be on DVD available at the gift shops. Employees volunteered on National Make a Difference day by joining other volunteers in a new effort to revitalize Tahlequah with a cleanup effort. The employment percentage for CNB this month is 73.5% Cherokee with 8.2% other Native American for a total Native American employment of 81.6%. He offered to answer questions from the report provided.
