#### CALL TO ORDER

Chair Byrd called the meeting to order at 9:05 a.m.

#### APPROVAL OF MINUTES

Councilor Taylor moved to approve the October 29th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

# REPORTS:

Marshal Service - Shannon Buhl

Marshal Buhl offered to answer questions from the report provided. Councilor Buzzard requested additional patrol in the Kenwood area late at night on the weekends due to theft and vandalisms. Mr. Buhl commented they are discussing cross deputizing with Chelsea. Additional discussion was held regarding cross deputization and patrolling.

Office of the Attorney General - Todd Hembree

Attorney General Hembree reported they would be filing their reply brief to the UKB seventy-six acre case. He introduced the newest Assistant Attorney General Courtney Jordan. He offered to entertain any questions.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin gave an update on the FOIA and GRA requests. Councilor Taylor gave appreciation for the summary spreadsheet showing the nature of the requests. It was requested the spreadsheet be provided on a monthly basis.

Tax Commission - Sharon Swepston

Ms. Swepston offered to address questions from the report provided. She gave an update on the Hunting and Fishing license implementation. Councilor Garvin requested clarification on the Cherokee Nation veteran tax card.

Self-Governance - Clint Hastings

Mr. Hastings offered to answer questions from the report provided. Councilor Buzzard inquired if the issue on the IRR roads on the Sequoyah campus have been worked out.

Gaming Commission - Jamie Hummingbird

Mr. Hummingbird offered to answer questions from the report provided. He provided updates on the tribes contributions to the state and reaching the billion dollar mark. He will taking a walk through the Roland facility tomorrow with the NIGC Chief of Staff. The gaming commission has set their meeting schedule for the upcoming year and will be provided to the Council. They continue to implement the changes as a result of the Attorney General's opinion on licensing. Councilor Thornton requested a copy of the gaming compact. Chair Byrd inquired how many tribes contribute to the State of Oklahoma. Councilor Buzzard requested clarification on what class gaming makes up this contribution.
