#### APPROVAL OF MINUTES

#### **REPORTS**:

1. Human Services Department - Marsha Lamb

Ms. Lamb reported on the process for increasing the burial assistance funding from the BIA. Councilor Byrd requested a list of the funeral homes where we currently have contracts. Mr. Jerry Snell gave a brief history of the burial program. He commented a support letter from the Council would help with the waiver needed to increase the funds. Councilor Walkingstick inquired how much of an increase the funeral homes are requesting. He also inquired about the funding spent on the program annually. Councilor Buzzard inquired about the community youth grant funding.

2. Community Services - Ron Qualls

*Mr.* David Pruitt reported in the absence of *Mr.* Qualls. He offered to answer questions from the report provided. Councilor Buzzard requested direction on a specific citizen's situation.

Housing Services - Gary Cooper 3.

Mr. Cooper announced they received notification on Friday of the receipt of an ICDGB Grant for rehabs for elders in the amount of \$800,000. He announced they would be bringing forward an amendment to the Indian Housing Plan to reflect the HUD VASH program for veterans. He discussed the President's budget which was recently released. Mr. Cooper provided an update on the status of the HUD Deputy Assistant Secretary for the Office of Native American Programs. Councilor Garvin inquired about expanding the Section 184 loan service area. Councilor Byrd inquired about the number of homes currently built. He requested an update on the transfer of the rehab employees to the Housing Authority from the Cherokee Nation.

Mr. Lynn offered to answer questions from the report provided. Councilor Byrd requested an appraisal for a chip and seal on the Johnson Prairie road.
