APPROVAL OF MINUTES OF PREVIOUS MEETINGS

Councilor Hargis moved to approve the February 16th regular session minutes as submitted. Councilor Baker seconded the motion. The motion carried.

STATE OF THE NATION Bill John Baker Principal Chief

Chief Baker commented on the blessing of having the college volunteers during spring break here at the complex and at the Head Start. He announced we have signed a joint venture with IHS that opens the way to build a 450,000 square foot clinic at W.W. Hastings hospital along with operational funding. The housing program has been reorganized placing the Housing Rehab under the Housing Authority of the Cherokee Nation. We have secured an \$800,000 HUD grant for more home rehab for the elders and disabled. Elven Cherokee Marshals were deputized as U.S. Marshals recently which is the largest number in more than one

hundred years. The 3rd anniversary of the Violence Against Women Act was celebrated recently here at the Nation. He gave special recognition to the Head of the Indian Health Service in Washington D. C. as she is a Cherokee citizen. He gave updates on the local school athletic programs. Chief Baker read a long list of Cherokee citizens who have passed over the last month and requested a moment of silence in their remembrance.

CHEROKEE WARRIOR VETERAN AWARDS

Monthly Reports:

Housing Authority - Gary Cooper

Mr. Cooper announced their next board meeting is scheduled for Thursday, March 24th at 5:30. He reminded everyone the Housing Authority will be closed on March 25th in observance of Good Friday. One week ago today the Housing Rehab Department transferred to the Housing Authority. He provided an update on the employees and services included within the transfer of that department. The Housing Authority has a monthly impact to over 6,000 Cherokee families with assistance through their various programs and services. As of March 1st they have 179 employees with 96% Cherokee employment and a 98% Native American employment. He offered to answer questions from the report provided.

Cherokee Nation Business, LLC - Shawn Slaton

Mr. Chuck Garrett reported on the financials for January. He recognized the top volunteers at CNB for the year. He announced Cherokee Cultural Tourism is accepting grant applications for spring education tours. Mr. Garrett reported of the 4,908 employees 73.1% are Cherokee citizens, 8.2% are Native American and a total of 81.2% total Native American employment. He offered to answer questions from the report provided.
