DISCUSSION AND POSSIBLE ACTION:

(A) WHAT CONSTITUTES SUFFICIENT BASIS FOR A COUNCILOR TO CLAIM TRAVEL TO AND FROM COUNCIL MEETINGS, INCLUDING TRAVEL FROM PERMANENT RESIDENCES AND FROM TEMPORARY WORK LOCATIONS OUTSIDE OF CHEROKEE NATION?

(B) MAY THE COUNCIL REQUIRE REIMBURSEMENT OF TRAVEL FUNDS, FOR TRAVEL TO AND FROM COUNCIL MEETINGS, FROM A COUNCIL MEMBER WHO DID NOT HAVE A SUFFICIENT BASIS TO CLAIM SUCH FUNDS?

Councilor Thornton stated if another Councilor doesn't wish to move forward with this item then he would table it indefinitely.

Councilor Thornton moved to table indefinitely. Councilor Baker seconded the motion. The motion carried.

2. TMP-273

DISCUSSION AND POSSIBLE ACTION: CEMETERY RESTORATION ASSISTANCE POLICIES AND PROCEDURES

Councilor Hargis move to approve. Councilor Snell seconded the motion. Councilor Baker voiced concern for those living outside of the jurisdiction not being able to obtain funding to take care of a cemetery within the jurisdiction. Councilor Thornton voiced concern for the requirement that there must be a federal identification number to apply. Councilor Hargis voiced concern for the requirement for the names, dates of birth and death on all within the cemetery.

Councilor Hargis moved to table. Councilor Vazquez seconded the motion. Chair Byrd requested all concerns be emailed to himself and/or the Council staff prior to the next meeting to they can be forwarded to the proper group. He requested someone from the Community Development Group to be present next month. The motion to table carried.

3. 16-025

AN ACT AMENDING LA-04-14 REVISING TITLE 26 ("ELECTIONS") OF THE CHEROKEE NATION CODE ANNOTATED

Councilor Vazquez moved to approve. Councilor Hargis seconded the motion. Chair Byrd reminded everyone we already had a motion and a second on this from the special session held on the 9th. This discussion will begin where the special meeting adjourned with page 29 §74. Attorney General Hembree began with the first amendment being in §78. Mr. Hembree provided a handout of a revised version of this section and Mr. Harvey Chaffin gave a brief overview of the changes. Chair Byrd reminded everyone the original motion to approve was by Councilor Vazquez and the second was by Councilor Hargis and they would be the ones to address friendly amendments.

Councilor Garvin made a motion for there to be a maximum of ten (10) absentee ballots brought in per person. Councilor Baker seconded the motion. The motion failed with the following roll call vote:

Councilor Austin offered a friendly amendment to strike "the voter or a person designated by the voter delivers" and insert "is delivered" following the ballot. The friendly was accepted.

After additional discussion and debate Councilor Walkingstick made a motion to keep the language as original. Mr. Hembree commented by parliamentary procedure the motion would be to restore the original language and it would kill the friendly amendment from Councilor Austin. Councilor Jordan seconded the motion. The motion carried by the following roll call vote:

In Chapter Article 3 §80A the changes were explained by Mr. Chaffin and were accepted with no objections.

In Chapter Article 3 §80B the changes were accepted with no objections.

In Chapter Article 3 §82 the changes were accepted with no objections.

In Chapter Article 4 §91 the changes were accepted with no objections.

In Chapter Article 4 §91A the changes were accepted with no objections.

In Chapter Article 4 §92 the changes were accepted with no objections which deletes the entire section.

In Chapter Article 4 §92 new section. The changes were accepted with no objections.

In Chapter Article 4 §93 the changes were accepted with no objections.

In Chapter Article 5 §101 the changes were accepted with no objections.

In Chapter Article 5 §102 the changes were accepted with no objections.

Section 2 of the Act the changes were accepted with no objections.

Mr. Hembree commented this concludes their work and the proposed changes of the loophole work group. The additional proposed amendments submitted by Councilor Lay will now need to be considered. These amendments are included in your packet. The first amendment proposed is in §43. Councilor Lay requested his proposed amendments be withdrawn.

Councilor Lay requested discussion on the timeline of filing. Mr. Chaffin commented the election date has been changed but not the filing date. He suggested a change in

§36.

Councilor Lay made a motion to accept the filing date suggested by the Election Commission as the first Monday in February and the first campaign donations can be accepted once the background checks are complete. Councilor Thornton seconded the motion.

Councilor Lay upon request split the motions. The first motion for discussion is for the filing date to be the first Monday in February. After discussion was held the motion carried with the following roll call vote:

Chair Byrd stated we are now voting on the entire proposed act as amended with all of the accepted friendly amendments. Councilor Buzzard requested clarification on the definition of "term" on page 4 new section §31.
