# CALL TO ORDER

Chair Byrd called the meeting to order at 1:03 p.m.

# INVOCATION

Councilor Thornton gave the invocation.

# APPROVAL OF MINUTES

Councilor Vazquez moved to approve the March 9th special session and the March 31st regular session minutes. Councilor Thornton seconded the motion. Councilor Taylor offered a friendly amendment to correct page 4 of the March 31st minutes in the next to the bottom paragraph to include "be withdrawn" at the end of the sentence referring to Councilor Lay's proposed amendments. The friendly was accepted. The motion carried.

#### AMEND THE AGENDA

Councilor Warner moved to amend the agenda to move old business items 4 and 5 along with new business item 1 prior to reports. Councilor Hargis seconded the motion. After the Chair's suggestion Councilor Warner amended his motion to address all business items prior to reports. The motion carried.

#### OLD BUSINESS

#### 1. <u>TMP-273</u> DISCUSSION AND POSSIBLE ACTION: CEMETERY RESTORATION ASSISTANCE POLICIES AND PROCEDURES

Councilor Vazquez moved to approve the revision provided in a handout today. Councilor Hargis seconded the motion. Councilor Taylor gave an overview of the proposed changes. Discussion was held on the requirement for an EIN#. Councilor Baker offered a friendly amendment under Funding Amounts to insert "any amount expended" after "receipts for" and to add "and account for remaining funds by January 1st" following "September 1st". The friendly was accepted. The motion carried as amended.

2. <u>16-038</u> A RESOLUTION CONFIRMING THE NOMINATION OF VALERIE J. ROGERS AS A GOVERNING BOARD MEMBER OF THE CHEROKEE NATION HOME HEALTH SERVICES, INCORPORATED

Councilor Hargis moved to approve. Councilor Vazquez seconded the motion. The motion carried. Ms. Rogers gave a brief overview of her background and offered to answer questions.

3. <u>16-039</u> A RESOLUTION CONFIRMING THE NOMINATION OF VALERIE J. ROGERS AS A GOVERNING BOARD MEMBER OF CHEROKEE NATION COMPREHENSIVE CARE AGENCY (PACE)

Councilor Hargis moved to approve. Councilor Taylor seconded the motion. The motion carried.

4. <u>16-046</u> A RESOLUTION AUTHORIZING THE ATTORNEY GENERAL TO COMMENCE LITIGATION FOR AN ACCOUNTING OF CHEROKEE NATION TRUST ASSETS

> Councilor Vazquez move to approve. Councilor Jordan seconded the motion. Attorney General Hembree gave an overview of the proposed Act. After discussion was held the motion to approve carried with no opposition.

1. <u>16-061</u> A RESOLUTION CONFIRMING THE NOMINATION OF PAMELA SELLERS AS CHEROKEE NATION ELECTION BOARD COMMISSIONER

Chair Byrd gave an overview of this Council nomination. Councilor Crittenden requested to be added as a sponsor. Councilor Thornton moved to approve. Councilor Vazquez seconded the motion. Ms. Sellers gave a brief overview of her background and offered to answer questions. The motion to approve carried with Councilor Hargis abstaining.

# 5. <u>16-025</u> AN ACT AMENDING LA-04-14 REVISING TITLE 26 ("ELECTIONS") OF THE CHEROKEE NATION CODE ANNOTATED

Councilor Vazquez moved to approve. Councilor Walkingstick seconded the motion. Councilor Lay handed out information from the constitutional convention and requested it be included in the minutes of this meeting. Attorney General Hembree provided a handout of the previously emailed new language for the definition of "term". He explained the reason for the new language. Councilor Vazquez clarified her motion to approve was to include the amended "term" language submitted by AG Hembree.

After lengthy debate and discussion was held the motion to approve with the amended term language carried with the following roll call vote:
