#### APPROVAL OF MINUTES OF PREVIOUS MEETINGS

Councilor Baker moved to approve the September 12th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

STATE OF THE NATION Bill John Baker Principal Chief

> Chief Baker announced he has just returned from At Large community meetings in California. Some of our key people including our Secretary of State, Chuck Hoskin Jr. and our Speaker Joe Byrd will be going to Standing Rock. The Cherokee Nation is taking fifty-four ricks of wood to Standing Rock. The Inter Tribal Council met last Friday and did a joint resolution in support of Standing Rock and their issues with the pipeline. Two elder summits were held this month. Election season is almost upon us and we have been registering non-patrician voters for Federal, State and Cherokee Nation elections. We have received a grant to replace six vans in our

Transit fleet all of which will be ADA compliant. A new community center has been dedicated in Nowata. Our Roads and Bridges program will help in Delaware County to replace the White Water Creek Bridge. They hosted the HUD Secretary of Native American Programs. With the help of the Cherokee Nation they are hiring more than 250 new jobs in South Coffeyville for a Texas based Star Pipeline and Products. Macy's fulfillment center in Owasso is hiring 3,500 seasonal employees and will retain 1,000 after the holidays. He honored the new Cherokee Nation Youth Ambassadors by requesting them all to come forward and introduce themselves. He announced Miss Cherokee is delayed at the Dallas airport and will arrive later. Chief Baker requested a moment of silence for the Cherokee citizens who have passed over the last month. Miss Cherokee Sky Wildcat arrived and introduced herself to the Council then gave highlights from her trip to the At Large community meetings in California.

#### Housing Authority - Gary Cooper

*Mr.* Cooper announced the next board meeting is scheduled for tomorrow at 5:30 here in Tahlequah. They have just wrapped up hopefully their final Negotiated Rule Making committee. He commented on the visit of the Deputy Assistant Secretary of Native American Programs at HUD. He reported they impact monthly 7,004 families with direct housing assistance as of the month of August. As of the end of August they have 248 employees of those 95.2% are Cherokee and a 98.4% total Native American employment. He offered to answer questions.

Cherokee Nation Business, LLC - Shawn Slaton

*Mr.* Chuck Garrett reported on the CNB financials for July. The dividend to the Cherokee Nation for the month of July was \$4,525,000. The non-dividend financial contribution to the Nation in July was \$336,774. The CNB job statistics for the month were a total work force of 6,546 with 1,791 of those being contract or temporary staff, of the 4,625 CNB employees 73.1% are Cherokee, 7.2% are Native American and a total 80.3% Native American employment. He announced several CNB and CN employees were recently honored as Oklahoma's next generation under thirty. The original musical of Nanyehi returns to the Hard Rock on the 11th and 12th of November. The Hard Rock Hotel and Casino earned a nomination for the International Entertainment Buyers Association this year. He offered to answer guestions.
