Chief Baker announced they have just returned from the Inter-Tribal Council in Thackerville. Last Saturday was the first graduating class of the Language Master Apprentice Program. The dedication of the Grove Casino is scheduled for tomorrow. This new casino has created 175 new jobs in Delaware County. In one month they will break ground on the long anticipated expansion at W. W. Hastings. Chief Baker read a list of Cherokee citizens who have passed over the last month and requested a moment of silence in their remembrance.

## Community & Cultural Outreach - Rob Daugherty

Mr. Daugherty, Director of the Community and Culture Outreach, gave an overview of his programs and highlights from their 2016 Annual Report. He touched on the COTTA Program, their training videos, their Facebook page, the annual Community Leaders Conference, their Volunteer Program, the At Large Organizations and those meetings, Cultural presentations, Community Work/Build Program, History and Preservation and The Cherokee Masters Language Program.

### Cherokee Nation Business, LLC - Shawn Slaton

Mr. Slaton provided highlights from their first quarter of this fiscal year. They submitted \$293,000 in tax collections back to the tribe. He recognized Amy McCarter, CNB Community Relations Manager, who gave a brief overview of their fund raising efforts for the Heart of a Nation Campaign. She requested the Community Impact Team Captains who are either CNB or CNE employees to introduce themselves. They presented to the Chief, Deputy Chief, Council and Cherokee Nation Health Administration with a check for \$21,406.67. Mr. Slaton announced the grand opening for the Cherokee Casino Grove will be held tomorrow. Osiyo Voices of the Cherokee People has launched Season 3. They currently have 6,686 employees and 4,742 once the contract and temporary employees are excluded. Their Cherokee percentage is 73.5% with 6.8% other Native American and a total Native American employment of 80.3%.
