1. Claremore Service Unit - George Valliere

2. Cherokee Nation Health Services - Connie Davis

Several questions and clarification was requested in regard to requiring insurance for elective surgeries. Councilor Crittenden voiced concern for patients being told there is a waiting list for

cancer patients. He inquired about a waiting list for appointments in the Women's Clinic. Ms. Davis requested to meet with Councilor Crittenden after the meeting to obtain additional information. Councilor Crittenden inquired if the CN had a methadone clinic. Councilor Lay requested an update on vacant positions at the Nowata and Ochelata clinics. Ms. Davis provided a report updating the vacancies at all of the facilities. Councilor Buzzard inquired about the Hepatitis shots. He requested they review the consent to treatment form in regard to who the records are available to see. Ms. Davis finished her report overview. She announced the groundbreaking for Hastings is the 17th of February at 11:00 a.m. Councilor Walkingstick inquired if the memo regarding communication had gone out as discussed last month. He requested clarification on the performance incentive for the doctors. Councilor Walkingstick inquired about exit interviews.
