Cherokee Nation Businesses - Shawn Slaton

Chair Taylor inquired if there were any specific questions for Mr. Slaton as we just heard a report from him last night at the Council meeting.

Financial Report/Treasurer Report - Lacey Horn

Mr. Jamie Cole reported for Ms. Horn. He announced the external auditors are on site for the fY2016 audit. He reminded everyone the list of surplus items is due back by next Monday for donations from the Council. He offered to answer questions from the report provided.

Career Services/Employment - Diane Kelley

Ms. Kelley reported on the new apprenticeship training program. She gave an update on the possible businesses in the pipeline currently. She reported on the soon to start Summer Youth Program. They are taking applications for the Tribal Internship Program. Daryl Legg was selected by the United States Department of Labor to be one of the National Employment Training Advisory Council Members. She offered to answer questions from the report provided. Councilor Vazquez requested information on the Tribal Internship Program be emailed. Councilor Crittenden inquired if we have assistance for bonding or licensing for a carpenter.
