CALL TO ORDER

Chair Snell called the meeting to order at 2:02 p.m.

1. Management Resources - Bruce Davis

A staffing update for her department was given. They requested information on upcoming community meetings if their presence is requested. Ms. Hill also provided an update on the Sequoyah Fuels case.
