Deputy Chief Crittenden gave the State of the Nation as Chief Baker was in Washington testifying before the Congressional Appropriations Committee in regard to Indian Country's needs in the federal budget process. The Cherokee Nation hosted the Annual Volunteer Firefighters Ceremony last week where more than \$458,000 was awarded to one hundred and thirty-one fire departments within our jurisdictional area. Our economic impact on the State of Oklahoma was released last month. Eight Boys & Girls Clubs were given \$195,000 in Washington, Delaware, Sequoyah, Rogers, Nowata, Cherokee, Mayes and Adair Counties. A proclamation was signed supporting Million Women Mentors. He requested a moment of silence to recognize those Cherokees who we have lost over the last month.

He reported on the March and April financials. The Hard Rock Hotel and Casino has been certified as a Triple A Diamond which is a great honor as only 6% of hotels achieve this ranking.
