REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb offered to answer questions regarding her report or the recent email pertaining to the hold on the NAHASDA funds for emergency assistance. Councilor Crittenden requested clarification on the hold on the funding.

2. Community Services - Ron Qualls

Mr. Qualls announced they are currently working on their 2018 program budgets. He offered to answer questions from the report provided.
