STATE OF THE NATION Bill John Baker Principal Chief

> Chief Baker started the night with requesting a round of applause for Gayle Miller on the new flooring in the Chambers. He recognized the Cherokee Nation Youth Council in attendance tonight for observation as to how the government works. The Summer Intern Program participants were each requested to stand and introduce themselves. Chief Baker announced the recently held 13th Annual Community & Cultural Outreach Conference had nearly five-hundred community leaders in attendance. They hosted the TOSS conference at NSU with over one-hundred and fifty regional teachers share practices. Ten new projects were funded focused on

STEM curriculum and development. He announced a federal judge ruled on the seventy-six acre UKB case. An EPA grant in the amount of \$75,000 was secured to help implement our natural resources and environmental preservation goals. The new fleet service center is open and will manage all upkeep on the Cherokee Nation's fleet both tribally owned and GSA vehicles. The Remember the Removal Bike riders will return this Thursday. An all employee appreciation day will be held on June 30th. An At-Large community meeting will be held in Oklahoma City this week and in Washington D. C. this weekend. He requested a moment of silence to remember the Cherokee citizens who we have lost over the last month.

Cherokee Nation Cultural Tourism will host free family friendly story telling events on Wednesdays in June at the Gazebo on the Cherokee National Capitol grounds. There is a new exhibit "The Pardoned" at the Cherokee Nation Prison museum. Mr. Slaton reported the employment numbers for the month with a total of 80.1% Native American employment.
