APPROVAL OF MINUTES

Councilor Walkingstick moved to approve the May 16th regular session minutes. Councilor Hargis seconded the motion. The motion carried.

REPORTS:

Marshal Service - Shannon Buhl

Mr. Danny Tanner offered to answer questions from the report provided in the absence of Mr. Buhl. Chair Byrd inquired if we have cross deputization in every county.

Office of the Attorney General - Todd Hembree

Ms. Nimmo provided a litigation update as requested. She offered to answer any other questions. Councilor Buzzard inquired about the possible gaming in Broken Arrow. Councilor Walkingstick inquired about the countersuit filed on us in the Opioid case. Councilor Walkingstick requested sensitivity in regard to the Keetoowah decision. Councilor Garvin requested an update on the motor fuels compact and possible negotiations. Several other questions were asked regarding motor fuels.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin gave an update on the FOIA and GRA requests. She offered to answer questions.

Tax Commission - Sharon Swepston

Ms. Swepston offered to answer questions from the report provided. Councilor Baker requested clarification on a situation of an At Large citizen needing a tag. He also requested the website be updated to include the Tulsa tag office location. Councilor Buzzard inquired if the sales tax for veteran's application is online.

Self-Governance - Karen Ketcher

Ms. Ketcher offered to answer questions from the report provided. Councilor Buzzard requested an update on the status of the NRCS. She commented the National Forestry Department will visit the pines to determine a solution.

Gaming Commission - Jamie Hummingbird

Mr. Hummingbird gave an overview on the recent publication from the NIGC where they are trying to clarify some language on class 2 games. He offered to answer questions from the report provided. Chair Byrd inquired how the Lewis Clark settlement would affect the employees at Hard Rock. Councilor Walkingstick asked about the renewal of the gaming compact. He also inquired as to what percentages we currently pay to the state. Councilor Buzzard inquired about Fair Meadows and how those payments are determined. Councilor Walkingstick inquired about the tribe trying to set up a gaming establishment in Broken Arrow.

Human Resources - Nason Morton

Mr. Morton gave an update on the current job openings and new hires. Councilor Walkingstick inquired if there is a way to eliminate the SHS teachers from having to complete time sheets during the summer. Councilor Hargis inquired if the number of terminations listed in the report includes transfers to other departments. She requested the number of employee transfers be included on future reports. Councilor Austin inquired about our leave policy for parents who adopt.
