They have worked with the BIA to put 240 acres of Cherokee land in Ochelata, which includes the clinic, in trust status. They have completed another successful year of the Summer Youth Program. He congratulated Deputy Chief Crittenden for being named the NSU Distinguished Alumni this year. He recognized Councilor Bryan Warner for being appointed to a Tribal Advisory Committee for the Centers for Disease Control. The Cherokee Language

Our 65th Cherokee National Holiday is fast approaching. Chief Baker gave an update on the Complex renovations. He read a long list of passings over the last month and requested a moment of silence.
