CALL TO ORDER

Chair Lay called the meeting to order at 4:05 p.m.

INVOCATION

Councilor Byrd gave the invocation.

APPROVAL OF MINUTES

Councilor Hargis moved to approve the August 15th regular session minutes. Councilor Byrd seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb gave an update on the clothing voucher program. She reported the coat voucher program would begin at the end of October. Councilor Taylor requested clarification on the contact person for Family Assistance.

2. Community Services - Ron Qualls

Mr. Michael Lynn offered to take questions from the report provided by Ron Qualls.

4. Roads & Transportation - Michael Lynn

Mr. Lynn reported on the Tenkiller School road, Leach Kenwood road, Moonshine road, Honey Hill and N.E. Ft. Gibson. He announced they have been working with Kim

Tehee on a government relations issue pertaining to the Tribal Technical Assistance Program at OSU in Stillwater regarding transportation and road construction training. Mr. Phillip Manus and four other employees have been called to Florida in hurricane relief efforts. He offered to answer questions from the report provided. Councilor Byrd inquired if our congressional contacts have been contacted with the issues. Councilor Buzzard requested clarification on a recent liquidated contractor submitting bids for upcoming projects.

3. Housing Services - Gary Cooper

Mr. Cooper gave an update on the College Housing Program. He provided a flyer on the HUD VASH program and gave a brief program update. He reported on his recent attendance at a regional housing association meeting. He offered to answer questions from the report provided. Several clarification questions were asked regarding the HUD VASH program.

Ms. Knight provided a handout of the policy changes to the Mortgage Assistance Program reflective of budget reductions in NAHASDA. She provided an update on the effects to the IDA program. There office has eliminated all travel except for the VITA program. She reported they have also eliminated 3 positions within their department. Following a detailed explanation of the changes she offered to answer questions. Councilor Buzzard inquired where the changes originated. Councilor Baker Shaw inquired if the background checks could be done through the Marshal Service. Councilor Buzzard requested as status update on the lighting project at the industrial park in Jay.

7. Indian Child Welfare - Nikki Baker Limore

Ms. Limore reported they are working on a prevention worker to keep children in their placed homes longer. She provided highlights on the Hero's for Hygiene program. Councilor Taylor requested clarification on response times on the report.

1. TMP-345 DISCUSSION AND POSSIBLE ACTION: THE COAT AND CLOTHING PROGRAM

Councilor Walkingstick gave an update that Wal-Mart is able to provide a restricted card for clothes only. An approval is needed from the Cherokee Nation Administration. Councilor Crittenden inquired about the timeline from Ms. Lamb. Ms. Lamb stated they are meeting with 2 other vendors this month. She also voiced concern about expiration dates on the Wal-Mart cards. Councilor Byrd requested she provide a list of pro/cons between Wal-Mart and Stage.

Councilor Walkingstick moved to table. Councilor Hargis seconded the motion. The motion carried.
