STATE OF THE NATION

Bill John Baker Principal Chief

Deputy Chief Crittenden gave the State of the Nation in the absence of Chief Baker. He announced Chief Baker is on his way back from the At Large community meetings held over the weekend in California. He congratulated Speaker Byrd for being re-elected as the Eastern Regional Area Vice President of the National Congress of American Indians. Last week a road project was dedicated for \$1.13ml near Sallisaw on Dwight Mission road. The Cherokee National Youth Choir won a Native American music award. An \$800,000 grant was received to build storm shelters at the head start

centers. He commended CNB employees for their volunteer work which enabled them to donate fifty portable defibrillators to area volunteer fire departments. He requested the assistance of Ms. Reva Bruner in the introductions of the 2017-2018 Little Cherokee Ambassadors. Deputy Chief Crittenden read a long list of Cherokees who have passed over the last month then requested a moment of silence.
