STATE OF THE NATION

Bill John Baker Principal Chief

Chief Baker reported on his testimony recently regarding the 1947 Act regarding blood quantum requirements on restricted lands. He reported on the ribbon cutting of the solar canopy. The Cherokee Angel project was once again a success. The 100,000 Cherokee Nation photo identification was given out recently. He commended the staff for participating in eleven Christmas parades over the last week. The 1998 Contract Support Cost Settlement has been determined with the tribe to receive \$8ml. He touched on the construction at W. W. Hastings Hospital. Chief Baker read a list of Cherokee citizens who have passed over the last month then requested a moment of

silence.
