Councilor Anglen moved to approve the November 14th regular session minutes as submitted. Councilor Vazquez seconded the motion. The motion carried.

REPORTS:

Cherokee Nation Businesses - Shawn Slaton

Mr. Garrett reported on the September financials. He provided an update on the Cherokee Springs Plaza plans. Details were given in regard to the road construction in front of Cherokee Plaza and South Ridge. They are continually looking at how to improve and meet market demand at the Hard Rock facility. Councilor Baker Shaw inquired about raising the dividend to assist with the contract health short fall. Councilor Byrd inquired about the hotel at Cherokee Plaza. Councilor Lay inquired about timelines for the Cherokee Plaza projects. Councilor Anglen inquired about the Sprung structure at Hard Rock. Councilor Buzzard asked about the acquirement of new businesses.

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn reported on the 4th of December she participated in a Treasury listening session regarding sales tax and bonds. They are in the process of the FY2017 yearend close and the auditors will soon be on site. Councilor Baker Shaw inquired about the odd for sales tax coming to the tribe. Councilor Walkingstick inquired about annexing to the city of Tahlequah at Cherokee Springs. Councilor Baker Shaw inquired about the hotel developer at the Cherokee Springs Plaza. She also inquired if we own the right of way at the Port of Catoosa. Councilor Walkingstick requested clarification on funding to the Marshal Service and Gaming Commission. Councilor Lay inquired about the ownership of Ross Construction.

Career Services/Employment - Diane Kelley

Ms. Kelley announced she would receive her diploma from the University of Oklahoma Economic Development Institute in a week. She stated three other employees within her department who are working toward their degrees at this time. Ms. Kelley gave some statistics from her department for the year.

Commerce - Anna Knight

Ms. Knight touched on highlights from the report. She reported on some of their incoming grants. She stated the CNB procurement numbers are still not included in the reports but they are working toward a solution for the issue.
