Vocational Programs/Talking Leaves Job Corp/Career Services - Diane Kelley

Ms. Kelley gave an update on the apprenticeship programs. She touched on the Job Corp recruitment drive. She reported on the businesses they are currently working with in Sequoyah County and Owasso. She offered to answer questions from the report provided. Councilor Hargis inquired about commuters within the Job Corp. She also inquired about the capacity at Job Corp and the number of open slots.
