CALL TO ORDER

Chair Taylor called the meeting to order at 3:12 p.m.

INVOCATION

Councilor Byrd gave the invocation.

APPROVAL OF MINUTES

Councilor Hargis moved to approve the March 29th regular session minutes. Councilor Vazquez seconded the motion. The motion carried.

REPORTS:

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton gave appreciation to the employees of CNB for reaching an all-time record for the month. He reported on the monthly financials. He gave highlights on the road construction and new casino build at Cherokee Plaza development. Mr. Slaton provided an update on the Sprung structure at the Hard Rock. In regard to Cultural Tourism the replica pavilion in Tahlequah should be ready no later than the first of July. The interior of our supreme courthouse renovations will soon be underway. Bids have been solicited to see the cost to renovate the Saline courthouse interior. He offered to answer questions from the report provided. Councilor Walkingstick requested clarification on the financials given. He also inquired how properties are identified for

renovation. Councilor Buzzard inquired about the possible renovation at the Saline courthouse. He inquired about estimated income with the ball and dice gaming changes. Lastly he asked about the possible expansion of the hotel at the Grove casino. Councilor Shaw inquired which casinos are making a profit. She also asked how often the CNB Board meets. Councilor Lay inquired about the Ramona and South Coffeyville casino upgrades in the near future. Councilor Crittenden voiced concern with the communication with the CNI employees. Councilor Smith commented on the machine placement at Hard Rock. Councilor Walkingstick inquired if the CNB Board participates in the bonuses. Councilor Byrd inquired about a future plan for Will Rogers Downs. Councilor Walkingstick requested clarification on the number of jobs at the new Tahlequah casino. Councilor Vazquez inquired about the restaurants within the new Tahlequah casino. Councilor Buzzard asked about the timeline for the replacement of sprung structure.

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn reported they are formulating budgets for FY2019. She offered to answer questions from the report. Councilor Shaw inquired if there were funds included with the donation from the Brenda Walker Trust.

Career Services/Employment - Diane Kelley

Ms. Kelley introduced our Project Director from the Dallas Regional Office, Cynthia Green. Ms. Kelley reported Friday was the deadline for summer youth applications. The summer youth is a six week program this year. They are collaborating with Health to recruit for the coding positions needed. The State Accreditation Officer for the State Department of Education was at our Job Corp center last week for our recertification. Next week four of our employees will be in San Antonio to receive their Economic Development Certification through OUEDI. She reported they will have a resource tent at the Stilwell Strawberry Festival. She provided highlights on two grants they are working on. Councilor Walkingstick requested additional information on the coding program.

Commerce - Anna Knight

Ms. Knight reported on the highlights from the Youth Entrepreneur day recently held. Chair Taylor requested an update on the pending grants. She requested clarification on the location for the business entrepreneur workshops in Pryor. Lastly she requested additional information on the Cherokee cultural art classes at ICW.
