#### APPROVAL OF MINUTES OF PREVIOUS MEETINGS

Councilor Taylor moved to approve the April minutes as submitted. Councilor Vazquez seconded the motion. The motion carried.

STATE OF THE NATION

Bill John Baker Principal Chief

Chief Bill John Baker recognized Mr. Darren Delozier who presented a gift to him and the Council of a children's book "Koko's Christmas Blessing". Mr. Delozier gave background of himself and how the book came about as well as future plans. Chief Baker announced keys were given to eleven families in Vinita to new homes. Almost a half of a million dollars was given out to the one hundred and thirty one Northeast Oklahoma Volunteer Fire Departments during our annual appreciation dinner. Our First Responders' were assisted by our Behavioral Health Department through an opioid grant. House Bill 1334 we advocated for at the State Capitol, authored by our Chief of

Staff Chuck Hoskin, was signed into law allowing our school districts with excess land to transfer that land to tribal housing authorities. Chief Baker testified last week before the U.S. House Subcommittee on appropriations and health care funding, a potential joint venture with BIE for Sequoyah High School, and the incorrect decision to classify tribal government as a racial group which would jeopardize our Medicaid reimbursements. Chief Baker read a list of Cherokee's who we have lost over the last month and requested a moment of silence.

#### Cherokee Nation Health Services - Dr. Charles Grim

Dr. Charles Grim reported last week was National Hospital week and National Nurses week. He read a list of the awards our staff has recently received. The Sam Hider Health Center is planning a kids powwow this fall. The Three Rivers Health Center is starting a community garden this week and sponsoring the Kay Lane Run. The Physical Therapy Department at The Vinita Health Center is planning a prevention program for ACL injuries. They will be getting a new facility at the Wilma P. Mankiller clinic.

#### Cherokee Nation Business, LLC - Shawn Slaton

Mr. Slaton reported on the February and March financials. He provided an update on the current projects including the Sprung Structure at the Hard Rock, the Tahlequah Cherokee Plaza and the interior Supreme Capitol building renovation. He also provided updates on all of the current activities, projects, contracts and awards for our businesses. He proudly announced our gaming and hospitality division has been working on gaming opportunities outside of the fourteen counties and have partnered with the Kaw Nation in a consulting and developing contract for their new casino. Mr. Slaton provided the current employment numbers with an overall Native American employment percentage of 80.2%. Councilor Lay requested clarification on the contract with the Kaw Nation. Councilor Walkingstick inquired about the status of the Arkansas casino proposal.
