STATE OF THE NATION

Bill John Baker Principal Chief

Principal Chief Baker gave an update on the Remember the Removal Bike Riders. The riders will be welcomed back at the Peace Pavilion in downtown Tahlequah on June 21st. The Peace Pavilion is a replica of the pavilion used by our ancestors on the original courthouse square before the capitol building was built. We are in collaboration with Northeastern State University on the Teachers of Successful Students program and STEM. Our first mobile food pantry for our military veterans and their widows was held with great success. The next mobile food pantry is scheduled in

August. He reported on the success in landing Amazon within our Cherokee Nation jurisdiction. Amazon will bring 1,500 jobs and provide a scholarship for employees with 90% of tuition paid up front. We will partner Chief Baker requested the Summer Youth Interns come forward and introduce themselves. Chief Baker requested a moment of silence following the reading of a long list of Cherokee's who have passed over the last month.

Mr. Chuck Garrett commented on his time with the Remember the Removal Riders. He announced in the month of March CNB generated more revenue and profits than any other month in our history. He reported on their tax contributions to the nation. The CNB Job statistics were given with a total Native American employment of 80%. He announced Hard Rock Hotel and Casino Tulsa has been nominated for Casino of the Year in the 53rd ACM Awards. He gave highlights on the Cherokee Nation Construction Services and the Cherokee Nation Red Wing businesses. Last month they contributed \$26,000 to replace the radio system for the West Siloam Police Department. He provided highlights on Cherokee Nation Cultural Tourism and their upcoming events. They are participating in the Nation Wide Blue Star Museum Program. He offered to answer questions from the report provided.
