STATE OF THE NATION

Bill John Baker Principal Chief Chief Baker announced they have just returned from Inter Tribal Council hosted by the Choctaws. We will be facing a major battle with the federal court in Texas ruling the Indian Child Welfare Act is unconstitutional. Head Start has broken ground on the first of six storm shelters. We will be partnering with the State Department of Agriculture to form a coordinating council on poultry growth. He gave highlights from our Hero Project. Our 4th Annual Elder Summit was held this last month. This weekend the At Large Community Meetings will be held in Southern California with a special ceremony to recognize the Cherokee Nation at the Los Angeles City Hall. On October 31st the official announcement of the new OSU Medical School Campus and it being the first on tribal land. He recognized the new Little Cherokee Ambassadors, Jr. Miss Cherokee and Miss Cherokee in attendance. Chief Baker commented our younger generation have great work ethic and will be able to carry on our culture and traditions. He read a long list of Cherokee citizens who we have lost over the last month and requested a moment of silence.

#### Cherokee Nation Business, LLC - Shawn Slaton

Mr. Garrett gave an overview of the non-dividend financials for the past month. CNB currently has a workforce of 7,027 employees and are permitted to apply preference to 4,478 of those positions. Of the preference applied positions 73% are Cherokee and 6.5% are Native American for a total Native American employment percentage of 79.5%. The topping out ceremony was held for the new Tahlequah casino. He announced Tru by Hilton Hotel will be east of Buffalo Wild Wings in the Cherokee Plaza. On October 18th there will be free admission to all Cherokee museums. Employee volunteers from CNB recently visited several schools to deliver donated supplies. The CNB employees have dedicated over 1,700 volunteer hours over the year. He offered to answer questions from the report. Councilor Taylor requested consideration for partitions or movable walls at the Will Rogers Downs event space. She also voiced concern for the gravel parking lot there causing issues for the elders. She and Councilor Austin presented Mr. Garrett and CNB with the winning Chili Cook-off trophy from the Mayes and Rogers County United Way.
