CALL TO ORDER

Chair Byrd called the meeting to order at 10:27 a.m.

INVOCATION

Councilor Hargis gave the invocation.

APPROVAL OF MINUTES

Councilor Taylor moved to approve the September 27th minutes as submitted. Councilor Vazquez seconded the motion. The motion carried.

REPORTS:

Marshal Service - Shannon Buhl

Mr. Buhl offered to answer questions from the report provided. Councilor Walkingstick requested an update on the Marshal pay scale.

Office of the Attorney General - Chrissi Nimmo

Ms. Nimmo announced the Murphy case has been scheduled for oral argument on November 27th. She and Councilor Smith visited Vian Public Schools on Indigenous Day and advocated for them to change their student handbook to allow a student to wear an eagle feather at graduation. She provided a background overview of ICWA and then provided an update on the recent ICWA ruling in Texas. Councilor Taylor inquired how the decision impacts the State and requested a background of the Texas case where the decision was made. Councilor Walkingstick requested clarification on

the eagle feather on graduation caps with it being traditional or religion. Councilor Hatfield inquired if they would go to other schools with the same issues. Chair Byrd requested a write up on our stand in regard to the ICWA issue to take to NCAI next week.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin reported there are seventeen total request with fourteen of those are FOIA with five of those outstanding, three of them are GRA's with one of them outstanding. The website isn't up to date at this time.

Election Commission - Marcus Fears

Mr. Fears gave an update on the numbers in the report. Chair Byrd requested their attendance at the Cherokee County community meeting. Councilor Crittenden requested a bulletin of the important dates to remember for the upcoming election.

1. <u>18-071</u>

A RESOLUTION RECOMMENDING REQUIREMENTS FOR SUPREME COURT JUSTICE APPOINTMENTS AND REQUEST FOR COMMENT FROM THE CHEROKEE NATION JUDICIAL BRANCH

1. <u>18-074</u>

AN ACT RELATING TO THE AMENDMENT OF TITLE 18 OF THE CORPORATIONS CODE REQUIRING COUNCIL APPROVAL OF CAMPAIGN CONTRIBUTIONS GIVEN BY CHEROKEE OWNED CORPORATIONS

Councilor Walkingstick made a motion to approve. Councilor Crittenden seconded the motion. Councilor Vazquez stated there is already a process in place. She stated this would be the first time to legislate a line item and she is opposed to this legislation. Councilor Crittenden inquired for the reasoning for the proposal. Councilor Walkingstick gave an overview for the reason behind the request. Discussion was held in regard to the process currently in place with respect to approval and notification. Some Council member requested the Board have more of a say in these contributions.
