REPORTS:

Chair Shaw requested Secretary of State, Hoskin Jr., come before the committee and give a breakdown of the federal government shutdown and the impact here at the Nation.

Claremore Service Unit - George Valliere

Mr. Valliere was not present to report do the federal government shutdown.

Cherokee Nation Health Services - Dr. Steve Jones

Dr. Jones provided a handout of an overview of the audiology program as a follow-up of questions from last month. Councilor Anglen inquired about full time ultrasound techs at the Nowata and Ochelata clinics. Councilor Vazquez inquired about replacement of

the batteries in the hearing aids. Councilor Crittenden requested an update on the renovation at the Wilma P. Clinic. Councilor Lay inquired about transportation from one clinic to another. He inquired about an uptick of phone calls on denials for contract health at Claremore. Councilor Buzzard relayed a concern he had received about being double billed. He requested a breakdown of the number of veterans seen at each clinic. He also inquired about the behavioral health waiting list and emergency situations. Councilor Hatfield inquired if elders have priority in the optometry clinic. She also inquired about the long waiting period for getting your initial appointment in optometry. Councilor Walkingstick inquired about the future use of the orthopedic and physical therapy building at Hastings. He inquired about the contract with OSU and if Indian preference would be practiced. He voiced concern for tearing down the current building to rebuild for the OSU medical school. Councilor Dobbins inquired about the compensation for the medical surgery nurses. Chair Shaw inquired about the salary for the lab employees once they move from the hospital to the clinic. She requested clarification on a cardiology patient. When will the orthopedic and optometry clinics move and what is the cost of these moves. When is the new clinic scheduled to open? Will the formulary be available online? What is the status of the medical network being available for our citizens.
