Councilor Walkingstick moved to approve the February regular session minutes. Councilor Duncan seconded the motion. The motion carried.

REPORTS:

Human Services Department - Marsha Lamb

Ms. Lamb offered to answer questions from the report provided. Councilor Crittenden gave appreciation for the effort to have the clothing vouchers redeemable at any store. He inquired if the application process would remain the same as last year. He requested an update on the incentive program issue. Councilor Shaw inquired about the differences between the Outreach for Elders and the Hospice/Home Health outreach program.

Community Services - Martha Ketcher

Mr. Billy Hix reported in the absence of Ms. Ketcher. Councilor Shaw requested clarification on repairs referred to in the report. She inquired about the status of a home with brown drinking water. Councilor Crittenden requested an update on the situation with the Cherry Tree water system.

Mr. Cooper offered to answer questions from the report provided. Councilor Buzzard inquired when the work would begin on the small elder homes in Hulbert. He commented there is an alternate design for 14 to be built by the cultural grounds and then some at Salina. Councilor Buzzard inquired how the locations are being determined. Councilor Shambaugh gave appreciation for his timely help on a situation. Councilor Crittenden inquired how to get some of the new rental units in other districts. Chair Lay inquired about the location where the homes were demolished. He also inquired if a two-year wait for homeownership is accurate. Councilor Shaw requested additional information on the housing for veterans program.

Mr. Lynn reported on the projects they are currently working on. Councilor Buzzard inquired about the contracts on two new roads. He also inquired about the liquidated damages for the Leach Kenwood road and the situation with that contractor.
