CHEROKEE NATION PUBLIC HEALTH
 Lisa Pivec, MS, Senior Director, Public Health

Ms. Pivec provided a handout of the Public Health highlights for June 2019 and gave an overview of the contents. Dr. Gahn reported on the surveys they have been performing referred to in the report. Ms. Pivec continued with the overview of the report provided. She also gave an update of the progress from the work group to get work out facilities in each community. She provided a handout pertaining to Community Physical Activity Assessment. Chair Dobbins requested the workgoups ideas and meetings be capsulated to explain how we have arrived at this report. She offered to answer questions from the report. Councilor Vazquez inquired about the locations of the open positions referred to in the report. She also inquired about starting a wings fitness club for walking in an area if there isn't one. Councilor Shaw requested clarification on how they are educating people on the HPV vaccine inquired how they obtain the participants in the surveys. Councilor Crittenden inquired if they would be able to assist with the community forums. He asked who would be formulating the questions and visiting the communities. He requested clarification on the process and if the results would come back to this committee to assist in the decisions moving forward. Councilor Buzzard inquired about the age group for the HPV vaccine and if there is any supporting data or a success rate. He asked for an elaboration of the

infrastructure of health departments as referred to earlier. Councilor Warner requested a brief explanation of what a tribal epidemiology center is along with pros and cons of how their funding is directed, and the future outlook.
