REPORTS:

Vocational Programs/Talking Leaves Job Corp/Career Services - Diane Kelley

Ms. Kelley announced this is National Manufacturing Month and this past week they participated in the chili cookoff in Pryor at the industrial park. This year they won two of the three trophies awarded. Chief Hoskin will be signing a Proclamation tomorrow at the Ray Corporation for putting the most Re-Entry participants to work. They will be visiting the Northeast Tech Construction Program as part of the Career Readiness Act. They will be rolling out some medical training programs with the Indian Capitol Technology including nursing, medical lab tech, medical assistant, and more. They will also be contacting some of the schools to provide training for biomedical engineering and medical coding. Ms. Kelley stated they plan to mirror the classes up North in the Spring. They have received the approval from the Department of Interior to combine the Department of Labor and Department of Education programs into the PL

102-477 program. She reported on their part of the way finder volunteers at the new outpatient clinic. An office will be opened in Muskogee within the next couple of weeks. Job Corp remains number one. Our fire program was notified they will receive additional staff due to the work they are doing for the Bureau and the State. She commented on the upcoming NCAI Conference and the many staff going to work.

Executive Director's Report - Ron Etheridge

Ms. Jennifer Pigeon report for Mr. Etheridge. She announced on October 22nd the College fair will be held here in Tahlequah. Applications for concurrent enrollment is open until December for Spring 2020. The Remember the Removal Bike Ride applications closed on Friday.
