## **REPORTS**:

Cherokee Nation Businesses - Chuck Garrett

*Mr.* Garrett reported on the August financials and the year-end. He provided an update on gaming in Arkansas. Councilor Shaw inquired if betting could take place this weekend on the Breeders' Cup race at Will Rogers Downs. She also inquired about the ratio of gaming dollars versus contract dollars at CNB. Councilor Byrd inquired about the slow start of the hotel build at the Cherokee Plaza. He inquired if the Ft. Gibson casino is back to normal in regard to revenue since the flood.

#### Financial Report/Treasurer Report - Tralynna Scott

Ms. Scott reported they are working on the year-end and the next month report will be the same as this month. She attended the NOFA Conference where the IRS held a dissertation with the tribes regarding taxation of tribally chartered entities.

Career Services/Employment - Diane Kelley

Ms. Kelley reported on the recent trip to NCAI. Councilor Byrd requested someone review the resolution considered from the Alaskans regarding the communities becoming a voting block. The TERO vendor fair will be on November 21st at Hard Rock. She provided an update on the office to soon open in Muskogee. Ms. Kelley gave an update on the Career Readiness Act. A proclamation signing took place in honor of Manufacturing Month. They are preparing to roll out numerous training classes in conjunction with the Career Readiness Act. Councilor Legg suggested a training program to use the pine trees we have an abundance of to make caskets.

#### Commerce - Anna Knight

*Mr.* Stephen Highers reported in the absence of Ms. Knight. He reported they are preparing for the Small Business Expo that takes place at the same time as the TERO Vendor Banquet. Chair Taylor inquired if someone would be at the vendor fair to answer questions for those who are considering becoming TERO certified. She also requested clarification on the KAWI café graduates in the report. Councilor Coates inquired if a tribally owned Cherokee bank has ever been explored.

#### T.E.R.O. CERTIFICATIONS

Councilor Vazquez made a motion to approve. Councilor Duncan seconded the motion. Councilor Deere voiced concern of one of the vendors up for recertification. Following some discussion the motion to approve carried with no changes.

Councilor Duncan requested \$350 to the Greasy Community Fellowship Organization, \$250 to the Proctor Community Organization, \$1,000 to the Adair County Resource Center, and \$700 split with Councilor Crittenden to Marietta School. Councilor Austin requested \$1,155 to Foyil Schools. Councilor Buzzard requested to Jay School \$750, to Jay JOM \$500, to Grove JOM \$500, Fairland School \$500, Spavinaw City \$750, Lighthouse Pregnancy Center \$500. Eucha Community Center \$400. Boys and Girls Club of Ottawa County \$750, Boys and Girls Club of Delaware County \$150, Jay America Radio Station \$500, Community Crisis Center \$500, and Souls Harbor Ministry \$500.
