STATE OF THE NATION

Chuck Hoskin, Jr. Principal Chief

Chief Hoskin announced the collaboration with Oklahoma State University continues as we celebrated the topping out of the OSU College of Medicine at Cherokee Nation. This first of its kind is on schedule to open for the fall of 2020 class. The Annual TERO Banquet was held to celebrate our Indian owned business and Cherokee artists. Tomorrow he and Howard Paden will go to the United Nations to speak about our efforts in indigenous languages. The Durbin Feeling Language Center is on track to open in 2020. He gave appreciation to everyone who adopted angels from the children's and elder's tree. Chief Hoskin recognized Cherokee citizen, Ollie Starr, for

being inducted into the Oklahoma Women's Hall of Fame. Ms. Starr was presented with a Pendleton blanket. Chief Hoskin read a list of Cherokees who we have lost over the past month and requested a moment of silence.

Chief Hoskin stated we have recently celebrated our strength as a nation through the economic impact report. He commented reminders should be given all the time to our fellow Oklahomans on the impact the Cherokee Nation has. Our position on the gaming compact is that it continues past the end of this year, this is the opinion of every tribal leader whose tribes are signatory to this contract. He stated we have always been willing to set down with the State of Oklahoma; we just are not going to do it with an arbitrary deadline held over our head. Speaker Byrd commented on the public relations in support of the tribes and the impact on the State. He commended Chief Hoskin on his leadership.
