AN ACT AMENDING LEGISLATIVE ACT #15-19 AUTHORIZING THE COMPREHENSIVE OPERATING BUDGET FOR FISCAL YEAR 2020 - MOD. 9; AND DECLARING AN EMERGENCY

Councilor Shambaugh moved to approve. Councilor Duncan seconded the motion. Treasurer Scott provided a powerpoint presentation of the CARES Act proposed spending plan for the Coronavirus relief funds. Chief Hoskin commented the Council was briefed in smaller groups regarding these funds yesterday. Councilor Nofire inquired if any of the funds appropriated within the budget modification last month had been utilized. He questioned and requested clarification on those funds and the funds requested within this mod as well. Councilors Patzkowski and Duncan requested clarification that the funds could not be used to replace lost revenue.
