Cherokee Nation Health Services - Dr. Steve Jones

Dr. Jones gave an overview of the report provided. Councilor Crittenden inquired if the ventilators are in as much demand now with COVID-19. Councilor Legg inquired about an elder who was on market place insurance which was cancelled, they were then enrolled in 1920 insurance, now the IRS is billing them for \$11,000. Councilor Shambaugh inquired if Home Health is still going into residences to assist patients. Councilor Buzzard voiced concern for dental appointments being cancelled when private dental facilities are preforming routine appointments. He inquired about the increase in children with COVID-19. Dr. Jones stated he would provide a report

showing the number of positive cases by age group. Councilor Buzzard voiced difficulty with the 580 area code calls going through to the new outpatient clinic. Chair Shaw inquired how often the COVID task force meets. Councilor Byrd inquired about the purpose of moving the refill center from Three Rivers. Councilor Nofire inquired if there are plans to expand the behavioral health care in regard to increased numbers of patients with depression due to the COVID-19. Councilor Smith inquired if the expansion of eyeglasses to the At Large would affect those already on the waiting list. Councilor Shambaugh inquired if the COVID-19 testing tent at the Salina Food Distribution had been replaced after the recent storm. Chair Shaw inquired if the patients who test negative for COVID-19 are contacted. She inquired if patients in the hospital are now allowed visitors. She requested clarification on the top three diagnosis. Lastly she inquired about the number of residence in the OSU medical school program.
