Cherokee Nation Health Services - Dr. Steve Jones

Dr. Jones gave an overview of the report provided. He also gave a COVID update, reported on a clinical trial coming to the Cherokee Nation. The flu clinic has begun for the season. He gave appreciation for all the hard work of the employees. Councilor Crittenden inquired if portable restrooms are available to family waiting on patients, about a family member being able to visit during major surgeries or hospital stays, about the accuracy of the COVID testing and about telemedicine. Councilor Duncan inquired about the top diagnosis by clinic not being listed in the report. He also inquired about how soon the results will be known in regard to the clinical trial. Councilor Byrd commended the staff for the outstanding job each of them do day in and day out. Councilor Austin gave appreciation to the introductions of new providers and staff on social media but suggested it be done more consistently and an email also be provided to the Council. Chair Shaw inquired about the number of patients being seen by telemedicine. She requested additional information on the new Deputy Medical Director. She inquired if sign on bonuses offered by others hurt in our recruiting processes. Chair Shaw inquired who pays for the drive thru COVID testing. Councilor Shambaugh inquired about what to do for families, who have had a member of the household test positive for COVID, sanitize their homes. Councilor Dobbins inquired if it a normal practice to release the names of our new hires. Councilor Deere inquired about the closest drive thru flu clinic to Tulsa.
