CALL TO ORDER

Chair Taylor called the meeting to order at 12:04 p.m.

INVOCATION

Councilor Duncan gave the invocation.

Councilor Deere made a motion to approve the October minutes as submitted. Councilor Jordan seconded the motion. The motion carried.

REPORTS:

Cherokee Nation Businesses - Chuck Garrett

Mr. Garrett offered to answer questions from the report. Councilor Duncan inquired when the schools are virtual and the parents must stay home is there a special policy due to COVID or is it just use the time you have. Mr. Stephen Bilby provided a Powerpoint presentation on the diversified businesses and then offered to answer questions. Councilor Deere inquired about margins to other contractors.

Financial Report/Treasurer Report - Tralynna Scott

Ms. Scott reported they haven't had their first close for this year yet to be able to report on those numbers. She reported is working closely with the courts and the Marshal Service to determine how to pay for the effects of the McGirt decision. They will be submitted additional modification requests to assist with the funds needed. They will need to use the carryover funding. They are looking at long term solutions for the funding shortfalls due to McGirt. She announced taxation is one of those possibilities. She offered to answer questions from the report. Councilor Legg inquired if taxation would be sales, property, or income taxes. Councilor Deere inquired if we should look for properties within our jurisdiction in high tax brackets. He inquired if all of our reservation land is now considered trust land. Councilor Shambaugh commented on the reference U.S. AG Barr made while here that is would be common sense that the tribe would get taxes. Councilor Buzzard inquired about the estimation of Cherokee Nation employees and CNB employees who pay state taxes. Councilor Byrd inquired about the projections on sales and land taxes by district.

Career Services/Employment - Diane Kelley

Ms. Kelley gave highlights from the report provided. She provided an update on how they will be presenting the TERO Award Banquet virtually. She offered to answer questions from the report. Councilor Duncan inquired if a training program has been started for laying fiber optic. He inquired if instructors were needed.

Commerce - Anna Knight

Ms. Knight offered to answer questions from the report provided. She stated since 2010 they have funded 334 businesses creating over 1,500 jobs. She provided information on the community loan program.
