REPORTS:

Human Services Department - Jennifer Kirby

Ms. Kirby offered to answer questions from the report provided. She announced Ms. Lou Stretch is available online for any ICW questions. Councilor Legg inquired about the timeline for the nutrition centers to be serving again. Councilor Byrd commented on the enormous task Ms. Kirby and her staff has taken on with all of the new COVID programs in addition to the regular workload.
