Chair Taylor called the meeting to order at 3:01 p.m.

REPORTS:

Cherokee Nation Businesses - Chuck Garrett

Mr. Garrett announced they are running strong and getting back to normal operations. He offered to answer questions from the report provided. Councilor Nofire inquired about bonuses or retention offers to keep our employees. He also inquired if we are in a hiring freeze for salary employees. He asked how many of the 8A contracts are staying within the states. Councilor Dobbins inquired when there would be new episodes of Osiyo TV. Financial Report/Treasurer Report - Tralynna Scott

Ms. Scott gave an update on the individual COVID payments. She offered to answer questions from the report provided. Chair Taylor inquired if any paper checks have been sent out yet. She inquired about tax implications of the \$2,000. Councilor Legg inquired about divorced parents issue with who puts in the information in the portal. Councilor Shambaugh requested clarification on the portal with the "pending" message. He commented he wished we would of gotten a heads up on the text message.
