APPROVAL OF MINUTES

Councilor Vazquez moved to approve the May minutes as submitted. Councilor Shaw seconded the motion. The motion carried.

REPORTS:

Management Resources - David Moore

Mr. Moore offered to answer questions from the report provided. Councilor Crittenden requested they visit a creek, on our land, in the bell area to see the erosion issues. Councilor Shambaugh inquired if they knew anything about a food distribution in the Kansas area today. Councilor Byrd gave appreciation for the work at the pow wow grounds. Councilor Shaw inquired who the OSU school of medicine would contact with facilities issues.

Real Estate Services - Ginger Reeves

Ms. Reeves offered to answer questions from the report provided. Councilor Buzzard requested a copy of all Cherokee Nation properties.

Environmental Programs - Tom Elkins

Mr. Harsha offered to answer questions from the report submitted by Mr. Elkins.

Secretary of Natural Resources & Environmental Programs - Chad Harsha

Mr. Harsha reported they have mailed out the last of the heirloom seeds and have planted additional crops to keep up with the demand. They are in the process of adding additional charging stations here at the complex and will have supplemental chargers at Sequoyah High School and West Siloam Springs. They have submitted their round 4 Volkswagen Mitigation Trust for additional funding. He provided an update on the landfill master plan. Mr. Harsha announced the Cherokee Nation is involved in litigation in support of the Eastern Band as an opponent party to the Catawba Nation regarding land in trust. He offered to answer questions from the report. Councilor Shaw inquired about the disposal of the electric car batteries. She also requested an update on the temporary hunting and fishing licenses for At Large citizens. Councilor Legg inquired about controlled hunts on the land in Sequoyah County. Councilor Deere inquired about the process for the returned hunting and fishing licenses. Councilor Shambaugh inquired if there would be a fee for special hunts on our land. Councilor Buzzard inquired how long a fully charged battery lasts on the electric buses and how long it takes to charge. Councilor Byrd suggested submitting a resolution in support of the Eastern Band of Cherokee Indians and their opposition of the Catawba Nation to Tri-Council.
