# APPROVAL OF MINUTES

Councilor Shaw made a motion to approve the June regular session minutes. Councilor Deere seconded the motion. The motion carried.

### REPORTS:

Cherokee Nation Businesses - Chuck Garrett

Chair Taylor announced Mr. Garrett is on standby if there are any questions since he reported to Council last night.

Financial Report/Treasurer Report -

Ms. Scott announced they are up to date on the \$2,000 COVID payments to the citizens. To date they have had 244,149 applications for the assistance. Chair Taylor inquired about the process. Councilor Byrd inquired about the elderly speakers submitting for the funding. Councilor Smith inquired about the percentage of paper check versus electronic payments. Councilor Shambaugh requested clarification during the process when you have the option to "decline". Ms. Scott announced the Cherokee casinos are cashing the checks free of charge with identification. Councilor

Austin inquired about cashing checks for minors. Ms. Scott gave clarification that the disaster relief payments will not count against SSI recipients. This decision didn't go into effect until April of 2021 so some may have issue if payments were received prior to the decision.

Career Services/Employment - Diane Kelley

Ms. Kelley expressed birthday wishes to Chair Taylor. She gave program update on the Summer Youth participants. She reported on a new grant. She offered to answer questions from the report provided.

Commerce - Anna Knight

Ms. Knight offered to answer questions from the report provided. She requested the Holiday Coordinator, Austin Patton, to give an overview of the upcoming 69th Cherokee National Holiday. Mr. Austin gave an explanation of the hybrid events this year due to the COVID pandemic.
