REPORTS:

Human Services Department - Jennifer Kirby

Ms. Killer offered to answer questions from the report provided. Councilor Crittenden inquired if the Senior Nutrition Centers are open. Councilor Nofire inquired about the Angel Tree. Councilor Smith inquired about volunteers to hand out food at the nutrition centers. Chair Shambaugh inquired if we are in litigation at this time with the UKB pertaining to ICW.
