#### STATE OF THE NATION

Chuck Hoskin, Jr. Principal Chief

> Chief Hoskin opened his State of the Nation with an update from the Domestic Violence Task Force. This month the Country is celebrating Native American Heritage. Today a Tribal Nations Summit was held for the first time in four years. Chief Hoskin provided an update on the Health and Wellness Fund Act. He spoke about the funds set aside for Cherokees who want to go to Career Tech. With the recent acquiring of the Greasy School building in Adair County, we will have our second immersion school. Today you will consider the passage of historic sums to health care construction, these funds be used to construct a new hospital in Tahlequah. The current W.W. Hastings Hospital will be repurposed for behavioral health. Chief Hoskin gave praise to CNB and Mr. Garrett for the success in Arkansas as we now hold the license needed to operate a casino in Arkansas. He gave an overview of the executive order on employee compensation he signed today.
