CALL TO ORDER

Chair Frailey called the meeting to order at 2:10 p.m.

INVOCATION

Councilor Joe Crittenden gave the invocation.

ROLL CALL

AN ACT AMENDING LA#7-97 AND LA#39-05; REVISING TITLE 26 ("ELECTIONS") OF THE CHEROKEE NATION CODE ANNOTATED

Chair Frailey stated the election law was tabled in the tribal council meeting back to the rules committee to consider suggestions for change under certain sections of the election law.

Melanie Knight stated the majority of the changes are corrections to references referring to the right constitution. Most of them are typographical or connecting references such as changing membership to citizen. By and large a lot of them are not substantive changes but the one substantive change Council should consider which was also discussed in full rules committee was separating out the districting section of this law because of the litigation that is ongoing and reserving that portion and passing the remainder so the Election Commission can go forward with the updated law.

Councilor Hoskin asked what purpose it serves to strike the districting from the legislation because in fact it is the law of the land right now. Isn't section 5 just restating what the law is now? Melanie stated the Chief would not want to agree to legislation at this point because the legislation is opposite to his position in the litigation and so he would find himself in a contradictory position if he signs off on a

law that is passed with districting in it.

Todd Hembree stated he would go through the changes with the Council in sequential of order.

Page 1: No changes to recommend.

Page 2: Section 3, Authority: add additional language to the end of the last sentence that would say "which became the organic law of the land on July 26, 2003. Councilor Bill John Baker moved to add language. Councilor Joe Crittenden seconded the motion. Motion carried.

Section 3A, Definitions: Item #1- At Large Registered Voter, third line, change the word "have" to "has". Item #6 – Constitutional Amendment, amend this definition to include section 3 of article 15, which allows the right of the people to provide a constitutional amendment. Councilor Bill John Baker moved to approve. Councilor David Thornton seconded the motion. Motion carried.

Page 3: Item #16 – recommend on the third line, delete the words "starting in the year 1979 and occurring every four years thereafter" and simply adding "as provided by law". Councilor Garvin moved to approve. Councilor Jack Baker seconded the motion. Motion carried. Also, add the language "and Section 3 of the Cherokee Nation Constitution" to the end of the last sentence of item 16. Item #17 – second line, insert language "and constitutional amendment" after the word "measure". Councilor Jack Baker moved to approve. Councilor Don Garvin seconded the motion. Motion carried.

Page 4: No changes to recommend.

Page 5: Section 5, Reserved: recommend adding language "reserved pending court determination in Smith vs. Election Commission et al. cv 09-65".

Councilor Buel Anglen moved to approve. Councilor Brad Cobb seconded the motion. Councilor Tina Glory-Jordan made a friendly amendment to insert the language "Reserved for future use" in section 5. Councilor Buel Anglen accepted the friendly amendment. Councilor Brad Cobb seconded the friendly amendment. Motion carried with Councilors Joe Crittenden, Meredith Frailey, Bill John Baker, and Chuck Hoskin, Jr. opposing.

Page 6: Chapter 2, Section 11, Cherokee Nation Election Commission: Item #A, Term – put original language of "or" back in the first paragraph.

Councilor Tina Glory-Jordan made a request to have Ms. Karen Graham and Michael McBride present to answer questions.

Page 7: No changes to recommend.

Page 8: Item #12 – recommends this item remain the same as written. Keep the original language as written. Language was in original law. Councilor Chuck Hoskin, Jr. moved to approve. Councilor Joe Crittenden seconded the motion. Motion carried.

Page 11: Section 14, Election Services Office: Item #C, the first line, the words

"a be" should read "be a".

Todd Hembree continued going through the sequential order of changes.

Page 11: Section 14, C: Councilor Jack Baker made a motion to put a period (.) after the following language "The Administator shall be under the direct

supervision of the Election Commission. capitalize "At" all times the Administrator shall maintain independence and report to the Council and the Principal Chief through the Rules Committee. Councilor Brad Cobb seconded the motion. Motion carried with Councilor Chris Soap opposing.

Councilor Jack Baker made a motion to strike "through the Rules Committee".

Councilor Brad Cobb seconded the motion. Motion carried.

Councilor Jack Baker made a motion to change the word "commission" to "staff" in the sentences that read "The Administrator shall have exclusive over the day to day operations of the Election Commission staff, including without limitation: direct supervisory authority over the Election Commission staff. Councilor Brad Cobb seconded the motion. Councilor Bill John Baker offered a friendly amendment to go back to strike out language which reads " Services Office" in both palces. Councilor Jack Baker accepted the friendly amendment. Councilor Brad Cobb seconded the motion. Motion carried.
