CALL TO ORDER

Chair Shambaugh called the meeting to order at 1:03 p.m.

INVOCATION

Councilor Patzkowski gave the invocation.

APPROVAL OF MINUTES

Councilor Vazquez moved to approve the March minutes as submitted. Councilor Deere seconded the motion. The motion carried.

REPORTS:

Marshal Service - Shannon Buhl

Marshal Buhl reported their special operations team has been very active over the last month. They are in the middle of hiring at this time. Councilor Callison inquired about law enforcement retirement for the Marshals. Councilor Patzkowski commended the Marshals for the youth hunt for foster children.

Office of the Attorney General - Sara Hill

Ms. Hill reported they would file an Amicus Brief in Castro Huerta on Monday. She offered to answer questions from the report provided. Chair Shambaugh commented on the meeting the Attorney General's office held with the Police Chief's in Delaware County.

FOIA-GRA - Gwen Terrapin

Ms. Terrapin reported there are three FOIA requests and no GRA requests to date and none are outstanding. The website has been updated.

6. 22-028 AN ACT REVISING AND RESTATING TITLE 26 ("ELECTIONS") OF THE CHEROKEE NATION CODE ANNOTATED

Councilor Smith made a motion to approve the substitute revision provided. Councilor Jordan seconded the motion. Councilors commented on inconsistencies and voiced concerns on several different sections. Councilor Nofire suggested another work group be formed. He questioned where the changes stemmed from. Council Attorney Young commented any changes made must go to the BIA for approval prior to the election.

Following additional discussion Councilor Vazquez moved to table for a month. Councilor Austin seconded the motion. The motion carried.

7. TMP-399 DISCUSSION AND POSSIBLE ACTION: CHEROKEE NATION SPORTS TEAMS FUNDING PROGRAM ASSISTANCE POLICY AND PROCEDURES

Councilor Callison made a motion to approve. Councilor Jordan seconded the motion. Mr. Jody Reece provided a list of changes proposed by the work group that met this morning. He went over the list and requested they be voted on in total. Councilor Austin offered a friendly amendment for appeals to be submitted in writing within sixty days from being notified of being ineligible. The friendly was accepted. Following discussion and clarification, the proposed changes with the friendly were accepted with no opposition.

8. TMP-400 DISCUSSION AND POSSIBLE ACTION: CHEROKEE NATION JUNIOR LIVESTOCK PREMIUM AUCTION FUNDING PROGRAM ASSISTANCE POLICIES AND PROCEDURES

Councilor Jordan made a motion to approve. Councilor Tehee seconded the motion. Mr. Reece provided a list of changes proposed by the work group that met this morning. Following discussion and clarification the proposed changes were accepted with no opposition.

9. TMP-401 DISCUSSION AND POSSIBLE ACTION: FORMATION OF A TRIBAL COUNCIL WORK GROUP FOR REDISTRICTING

Councilor Deere made a motion to enter discussion. Councilor Jordan seconded the motion. Councilor Deere gave an overview and background for the agenda item.

Following discussion Councilor Austin made a motion to form a work group of Council Committee Chairs who are not up for re-election. Councilor Jordan seconded the motion. The Work Group will consist of Councilors Shotpouch, Crittenden, Dobbins, Shambaugh, Vazquez, Austin and Jordan. The motion carried.
