### CALL TO ORDER

Chair Shambaugh called the meeting to order at 1:05 p.m.

#### INVOCATION

Councilor Shotpouch gave the invocation.

#### ROLL CALL

#### APPROVAL OF MINUTES

Councilor Vazquez moved to approve the March regular session minutes. Councilor Patzkowski seconded the motion. The motion carried.

#### **REPORTS**:

Marshal Service - Shannon Buhl

Marshal Buhl reported on the newly opened twenty positions for Marshals and a Special Officer. He offered to answer question from the report provided. Councilor Callison requested the information for the Marshal openings be provided to the Council the help get the word out. Chair Shambaugh requested clarification on the Special Officer duties.

Chair Shambaugh inquired about a Tulsa World article pertaining to a judge making a rule affirming the Curtis Act.

FOIA-GRA - Gwen Terrapin

*Ms.* Terrapin reported there are four FOIA requests and no GRA requests at this time. All requests are up to date and the website has been updated.

*Councilor Deere offered a friendly amendment to remove a portion of Section 37A. Following lengthy discussion the friendly amendment was accepted.* 

Councilor Coates made a motion to go through the revisions paragraph by paragraph. Councilor Nofire seconded the motion. The motion failed by the following roll call vote:

Councilor Deere withdrew his friendly amendment to strike a portion of Section 37A. Councilor Nofire offered a friendly amendment to strike the portion pertaining to independent expenditures. The friendly was not accepted by the mover Councilor Vazquez. Councilor Nofire offered a friendly amendment to strike Section 31B Candidate Prerequisites for filing. The friendly was not accepted by mover Councilor Vazquez. Following additional discussion Councilor Crittenden called for the question.

The motion to approve substitute version 4 as submitted carried with Councilor Nofire opposed.
