Councilor Shotpouch commented on her attendance at the First Speakers Meeting recently held. Councilor Tehee inquired about the naming of the Greasy Immersion School.

Community & Cultural Outreach - Kevin Stretch

Mr. Stretch announced the CCO Annual Conference would be held August 6th virtually. They have 750 pieces of Cherokee artwork to give away to the organizational leaders.
