CALL TO ORDER

Chair Snell called the meeting to order at 11:25 a.m.

APPROVAL OF MINUTES

Councilor Anglen moved to approve the March 15th regular session minutes. Councilor Crittenden seconded the motion. Motion carried.

REPORTS:

3. Environmental Programs - Tom Elkins

Mr. Elkins gave an overview of his report and offered to answer questions. He gave appreciation for allowing him to report first.

1. Management Resources - Angela Drewes

Ms. Drewes offered to answer questions from her report. Councilman Buzzard inquired about the American Burying Beetle surveys that are required and how Natural Resources is working with the Fish and Wildlife Department on a process that would not cause project delays on our end. Ms. Drewes and Mr. Pat Gwin explained

the process that we are currently working through to enter into a conservation easement on some of our land that will not be developed in exchange for not having to conduct surveys on those lands that we will be. The land being considered is the Southern portion of CMS bordering Sequoyah County. Ms. Drewes announced a video of the Natural Resource and Realty projects will be played during lunch. A RESOLUTION AUTHORIZING A GRANT OF EASEMENT FOR RIGHT OF WAY OVER, IN UPON & ACROSS USA IN TRUST LAND IN DELAWARE COUNTY BETWEEN CHEROKEE NATION AND RONNY & CLAUDIA SWEGER FOR AN ACCESS (INGRESS & EGRESS) EASEMENT

Ms. Donelson announced Mr. Sweger purchased property that was land locked and was going to cross our tribal tract. She announced the found a way for him to enter crossing 600 feet instead of 5,000 feet. She announced they are not requesting compensation to the Nation since Mr. Sweger did the grader work, survey and fence. The easement is only to the Swegers, is non transferable and is for a period of twenty-five years. Councilor Buzzard moved to approve. Councilor Cowan Watts seconded the motion. Councilor Glory-Jordan voiced concern for the Nation getting the reputation that we will give easements on land locked land. She commented people will purchase landlocked land cheap and obtain an easement from the Nation then the property becomes more valuable. Ms. Donelson commented that is why the lease is non transferable.

The motion carried with Councilors Glory-Jordan and Frailey opposed.
